Dear parties:

I write in regard to the above appeal filed with the Office of Open Records (OOR) under the Right-to-Know Law, 65 P.S. §§67.101 *et seq.*, ("RTKL"). Please be advised that the appeal is dismissed for lack of jurisdiction.

The Request dated March 2, 2011 was directed to the Clinton County Clerk of Court, a judicial agency. Pursuant to Section 503(b) a judicial agency is to designate an appeals officer to hear appeals related to Right-to-Know requests. The judicial agency appears to want the OOR to act as its appeals officer. The OOR is statutorily required to hear appeals for local and Commonwealth agencies only. 65 P.S. § 67.503(a). The OOR has not accepted a designation to hear appeals of any judicial or legislative agencies. Therefore, the appeal is not properly before the OOR and is dismissed for lack of jurisdiction.

The file is now closed and no further action will be taken. This final determination is binding on the parties. Within thirty (30) days of the mailing date of this Determination, either party may appeal to the Clinton County Court of Common Pleas. All parties must be served with notice of the appeal. The Office of Open Records also shall be served notice and have an opportunity to respond according to court rules. 65 P.S. §67.1302.


